Subject: Processing of Appointments of Non-Regular Faculty at the CU Level

We would like to inform you that effective immediately, all applications for appointment of non-regular faculty, regardless of age or position (lecturers, professorial lecturers, adjunct professors, etc.) shall be processed at the CU level. Please refer to the attached Memorandum No. OSU 13-29 on the Authority of the Chancellors to Appoint Professorial Lecturers beyond age 65.

The revised OVPAA Form 3.0, enclosed here as well, will still be included as documentary support to the applications for appointment of non-regular faculty beyond the age 65 and for the extension of appointment of faculty members who have reached compulsory retirement. This form will provide an overview of the unit's hiring needs and their plans for developing their faculty members to eventually assume the teaching responsibilities in the unit. However, OVPAA Form 3.0 for non-regular faculty need not be submitted to the OVPAA. The form, along with the other requirements, will be submitted to the OVPAA only for the extension of regular faculty beyond compulsory retirement.

Authority of the Chancellor to Appoint Professorial

Lecturers Beyond Age 65

May I remind the Chancellors to exercise their delegated authority with respect to the appointment of Professorial Lecturers beyond age 65 based on the following:

1. Section 10.9 of the Handbook on Existing Delineation of Authority in the University on the Delegated Authority to the Chancellors, , p.27:

"10.9 appointment of lecturers, senior lecturers, professorial lecturers, special lecturers and consultants (1114th BOR Mtg., 11/27/971", and

2. Section 13 (I) of RA 9500 (UP Charter)on the Powers and Duties of the Board of Regents:

> "To extend, with their consent, the tenure of faculty members of the national university beyond the compulsory retirement age, any other provision of law to the contrary notwithstanding, on recommendation of the units upon endorsement of the President of the national university, whenever their services are especially needed: Provided, however, That no extension of tenure shall be made beyond the age of seventy (70)."

Per opinion of the Office of the Vice President for Legal Affairs, Section 13 (I) of RA 9500 applies only to extension of tenure of regular fact, the Board of Revents beyond 65 years old (but not over 70). NOTATION
